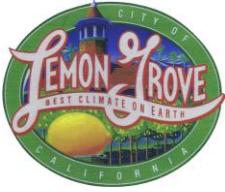

CITY OF LEMON GROVE MEASURE T OVERSIGHT COMMITTEE

Purpose:

The Measure T Oversight Committee acts as an advisory/focus group to the Lemon Grove City Council on the Measure T: Lemon Grove Sales Tax Measure. Five (5) committee members are needed to review and report on City compliance with the terms of Ordinance No. 466 or the Lemon Grove Municipal Code Chapter 3.18, and each annual Measure T Spending Plan presented to and approved by the City Council.

Membership:

The Measure T Oversight Committee can be comprised of one (1) Lemon Grove business owner and four (4) residents that are appointed by the City Council. Committee members will serve a staggered 4-year term. Two (2) of the five (5) members will have an initial term of 2 years to allow for the staggering of the 4-year term.

Committee members are open to Lemon Grove residents and business owners.

Meeting Time/Location:

The meeting dates and times are to be determined by City Council. Meetings will be held at the Lemon Grove Community Center, 3146 School Lane, Lemon Grove, CA. Members will attend a minimum of four (4) meetings a year. Members are also encouraged to attend the budget and financial audit meetings of the City Council as well as the City Council goal setting workshop. Measure T Oversight Committee meetings will be publicly noticed and subject to the Brown Act.
