I am a consumer justice and a housing rights lawyer. I have dedicated my time to serving low-income families, communities of color, and senior citizens. I ran the Consumer Protection Division at the Legal Aid Society of San Diego representing people fighting against fraud, financial elder abuse, and student loan and medical debt.

I lead the Housing Rights Project at the University of San Diego Law School, where we provide free legal services to marginalized communities for eviction defense, foreclosure prevention, and fighting fraud that causes housing instability. The goal is to keep people in their homes and help the unsheltered obtain a place to live.

Frustrated with the insufficiency of laws as they are to protect hard-working, low-income families, I have engaged in legislative rulemaking and policy work in California and on the national level. I have spent years advocating for laws to help financially struggling people.

For my work on saving peoples' homes and fighting businesses that engage in deceptive business practices, I was awarded the Consumer Advocate of the Year by the Consumer Attorneys of San Diego and honors from the World Justice Project for my work to ensure access to justice for all during the pandemic.
